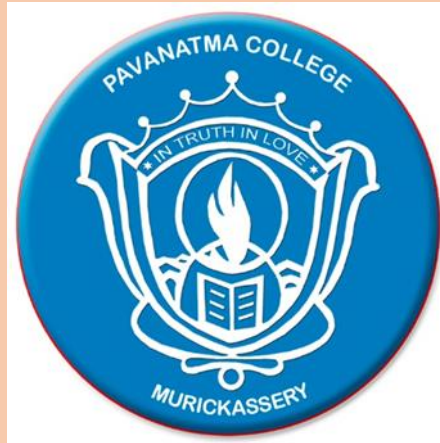

MEASURES TO CATER TO THE NEEDS OF ITS DIFFERENTLY ABLED STUDENTS

Pavanatma adopts the following measures to cater to the needs of its differentlyabled students.

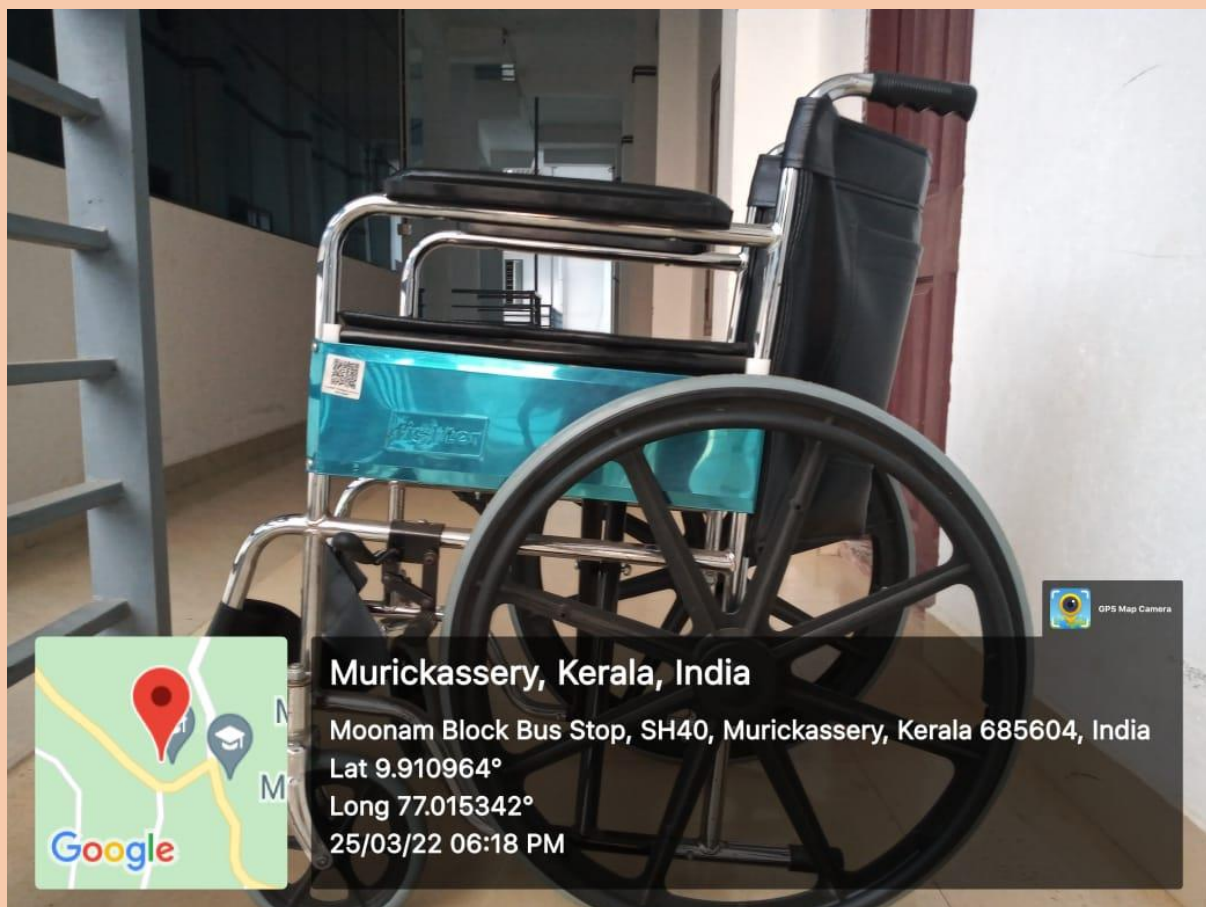
1. 1% of seats are reserved for each of the three sections of Persons with Disabilities category
 1. Blind
 2. Deaf
 3. Orthopaedically Challenged
2. Provision is made for interchange of seats if candidates are not available in a particular category in a year.
3. A relaxation of 5% of marks in the qualifying examination from the prescribed minimum is allowed for students of this category.
4. EOC organizes special counselling and lectures for the students of this category.
5. Remedial coaching organized for slow learners is extended to this category of students also.
6. A ramp has been built in the campus for the use of students of this category.
7. During examinations, help of scribes is being provided to those having vision problem.
8. Library books are issued at their seats on demand. Provide barrier free access to building. All circulation routes need to be wide enough and step free to allow free access design and height of tables chairs need to be easy to use. A certain number of tables and chairs should be adapted for physically challenged proper signage and way finding system. Barrier free services at the circulation desk. A special foot path (ramp) providing for physically challenged students. Popular guideline accessible disabled user flexible and longer loan periods. Allow the disabled students to authorize their supporting or helping workers to borrow books, collect holds or photocopying receipts and pay fines on their behalf. Provide assistance with the use of library computers, catalogue or other library equipment. Meet their reference questions in a kind manner. Provide assistance with printing from library computers with emailing search results.

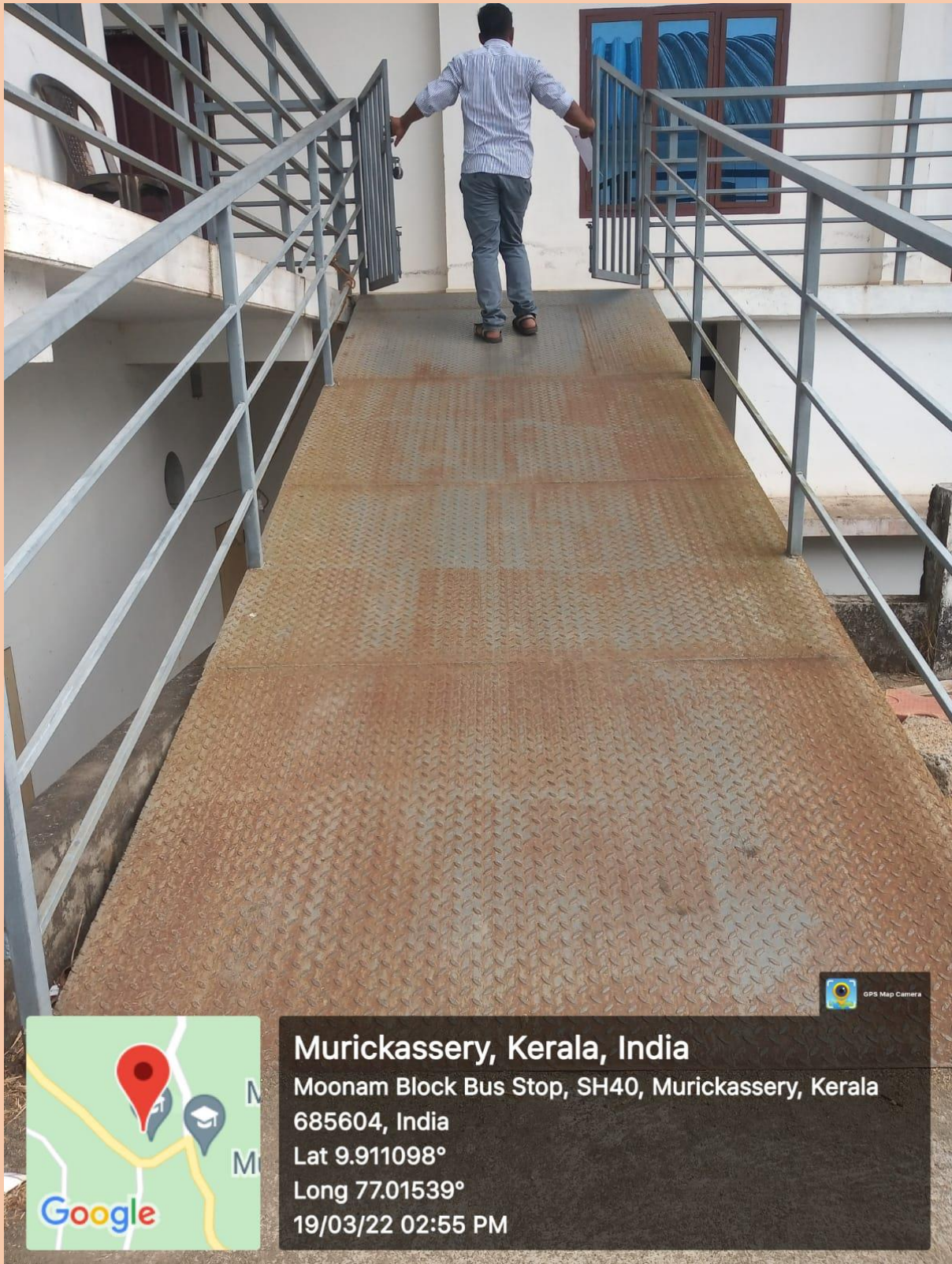

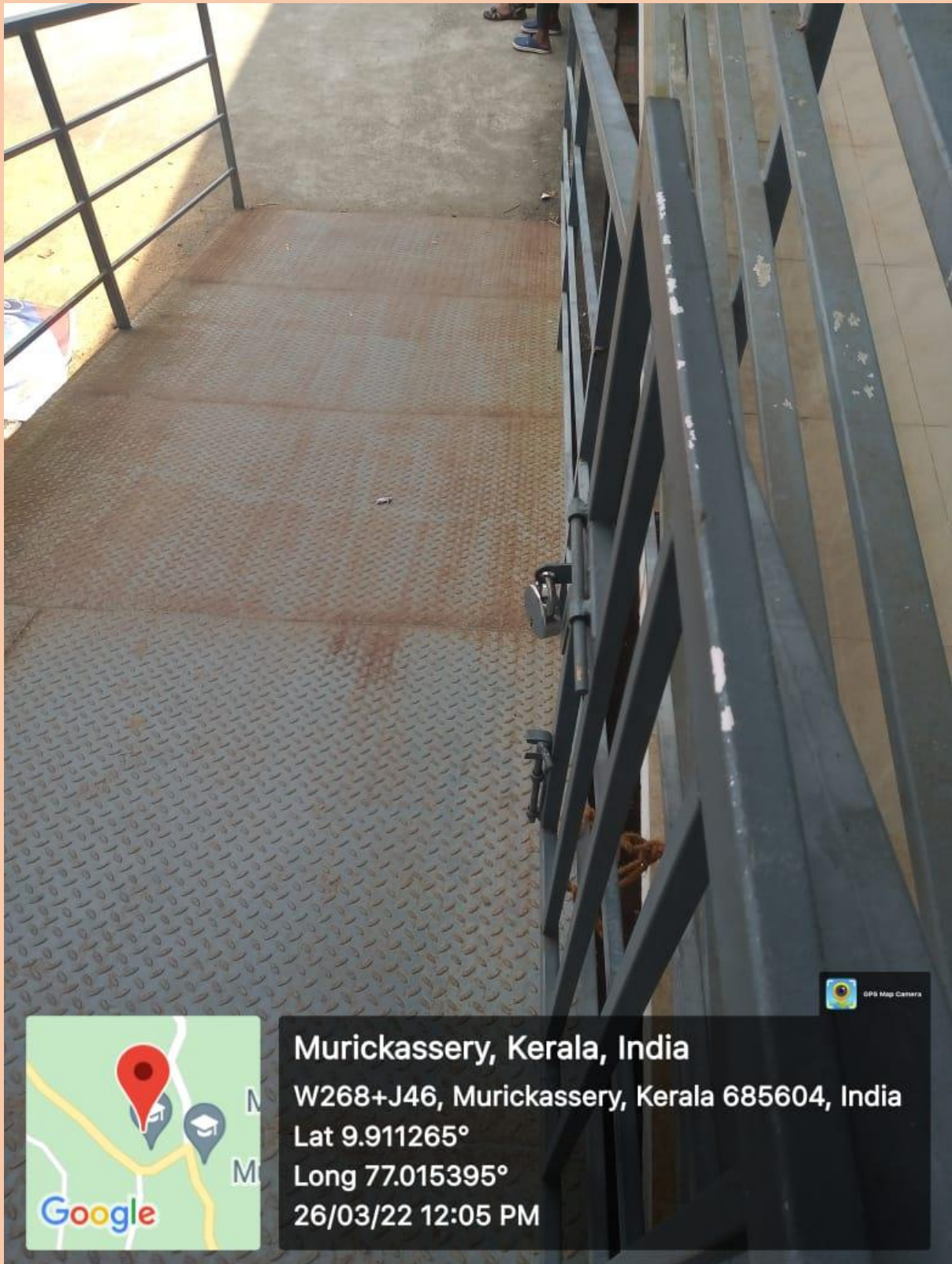

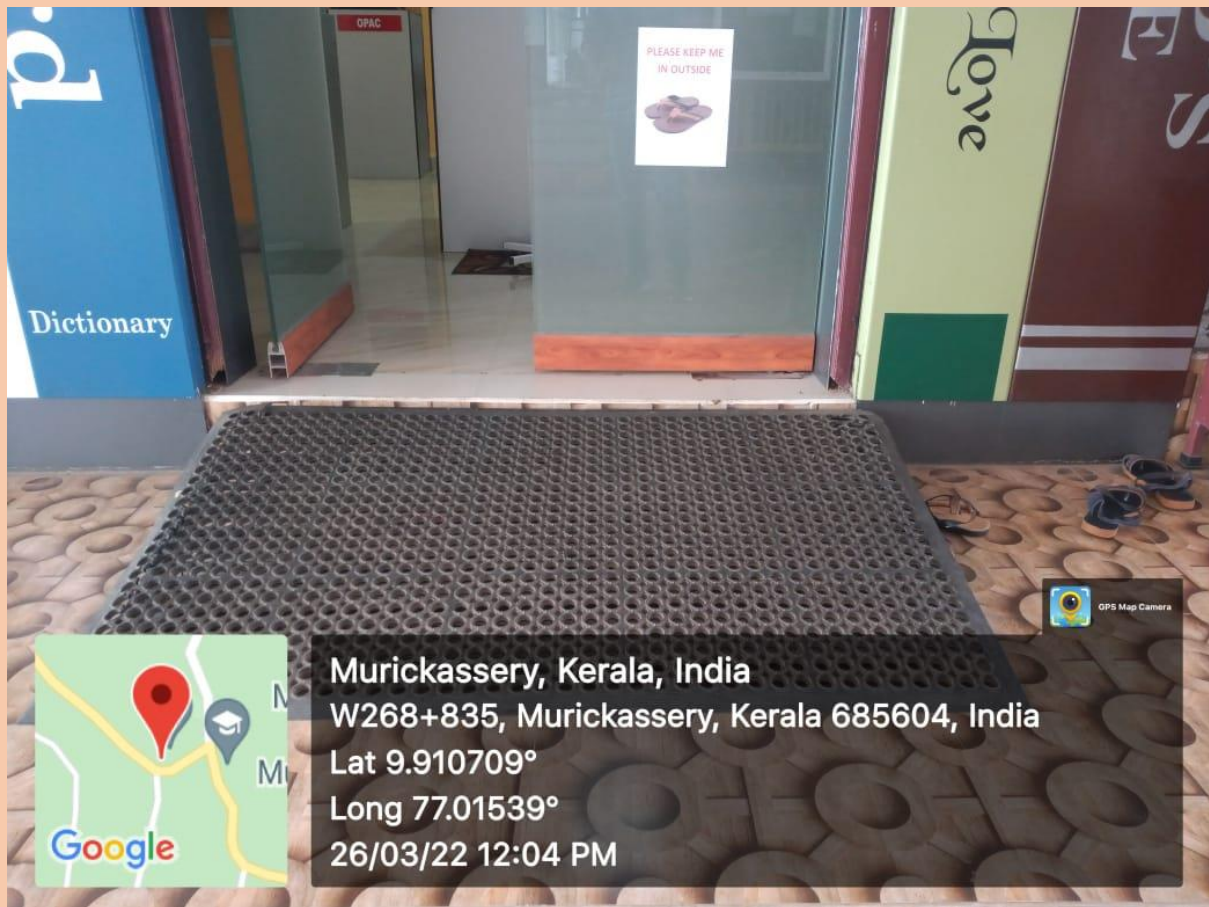
